**JUDGMENT ENTRY DECLARING DEFENDANT
WILLIAM R. WILSON A VEXATIOUS LITIGATOR**

Upon Motion of the Plaintiff, this Court's Memorandum of Decision dated April 15, 2021, and for good cause shown, it is hereby **ORDERED** that, pursuant to Section 2323.52 of the Ohio Revised Code, Defendant William R. Wilson is declared to be a vexatious litigator, and consistent with that designation, Defendant William R. Wilson is **ORDERED** indefinitely prohibited from doing any of the following without first obtaining leave of this Court to proceed:

- A. Instituting legal proceedings in the Court of Claims or in a Court of Common Pleas, Municipal Court, or County Court;
- B. Continuing any legal proceedings that he has initiated in any Ohio trial court prior to the entry of this Order;
- C. Making any application, other than an application for leave to proceed under Section 2323.52(F)(1) of the Ohio Revised Code, in any legal proceedings instituted by him or another person in any of the Ohio trial courts listed above; or

D. Instituting or continuing any legal proceedings in the Court of Appeals without first obtaining leave from the Court of Appeals pursuant to Section 2323.52(F)(2) of the Ohio Revised Code.

The Clerk of Courts, Muskingum County, Ohio is hereby **ORDERED** to send a certified copy of this Judgment Entry to the Supreme Court of Ohio for publication pursuant to Section 2323.52(H) of the Ohio Revised Code.

The Defendant is **ORDERED** to pay all costs associated with this case.

This Judgment Entry constitutes a Final Appealable Order in this action. Pursuant to Civ. R. 54(B), the Court finds there is no just reason for delay.
