## MERIT DECISIONS WITH OPINIONS

**2012-0438. Leopold v. Ace Doran Hauling & Rigging Co., Slip Opinion No. 2013-Ohio-3107.**

Cuyahoga App. No. 97277, 2012-Ohio-497. Judgment affirmed.

**2012-1709. Disciplinary Counsel v. Underwood, Slip Opinion No. 2013-Ohio-3118.**

On Certified Report by the Board of Commissioners on Grievances and Discipline, No. 12-051. Arica Lynn Underwood, Attorney Registration No. 0067664, is suspended from the practice of law for one year, with the entire suspension stayed on conditions.

## MOTION AND PROCEDURAL RULINGS

**2012-1020. Cleveland Mun. School Dist. Bd. of Edn. v. Cuyahoga Cty. Bd. of Revision.**

Board of Tax Appeals, Nos. 2008-K-1228, 2008-K-1233, 2008-K-1243, and 2008-K-1244. This cause is pending before the court as an appeal from the Board of Tax Appeals.

Upon consideration of the joint motion to remand this case to the Ohio Board of Tax Appeals to implement the settlement, it is ordered by the court that

the motion is granted and this case is remanded to the Board of Tax Appeals so that the board may take further action as appropriate.

It is further ordered that a mandate be sent to the Board of Tax Appeals to carry this judgment into execution and that a copy of this entry be certified to the Board of Tax Appeals.

**2012-1774. Lingo v. State.**

Cuyahoga App. No. 97537, 2012-Ohio-2391. This cause is pending before the court as a jurisdictional appeal.

Upon consideration of the motion for leave to participate in oral argument of amici curiae, Thomas E. Day Jr., Victoria Dailey, and Lisa Mastrangelo, it is ordered by the court that the motion is denied.

**2013-0661. Howkins v. Walsh Jesuit High School.**
