**2012-2069. Columbus Bar Assn. v. Gill, Slip Opinion No. 2013-Ohio-4619.**

On Certified Report by the Board of Commissioners on Grievances and Discipline, No. 12-007.

Sterling Everard Gill II of Columbus, Ohio, Attorney Registration No. 0034021, is suspended from the practice of law in Ohio for two years, with the second year stayed on conditions.

### **2011-0451. State v. Herring.**

Mahoning App. No. 08MA213, 2011-Ohio-662. This cause is pending before the court as an appeal from the Court of Appeals for Mahoning County.

Upon consideration of the motion for admission pro hac vice of Andrea D. Lyon, it is ordered by the court that the motion is granted. Pursuant to Gov.Bar R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days of the date of this entry.

### **2012-1611. State v. Wine.**

Auglaize App. No. 2-12-01, 2012-Ohio-2837. This cause is pending before the court as an appeal from the Court of Appeals for Auglaize County.

Upon consideration of the joint motion of appellee and amicus curiae, Ohio Attorney General Michael DeWine, for divided oral-argument time, it is ordered by the court that the motion is granted, and amicus curiae shall share the time allotted to appellee.

### **2013-1088. Lincoln Elec. Co. v. Travelers Cas. & Sur. Co.**

Certified Question of State Law, United States District Court, Northern District of Ohio, Eastern Division, No. 1:11CV2253. This cause is pending before the court as certified question of state law from the United States District Court, Northern District of Ohio, Eastern Division.

Upon consideration of petitioner's motion to transmit the record pursuant to S.Ct.Prac.R. 9.06, it is ordered by the court that the motion is granted. The clerk of the United States District Court for the Northern District of Ohio shall transmit a copy of the record in case No. 11CV2253 within 20 days of the date of this order. Those portions of the record under seal with the United States District Court shall remain under seal.

Upon consideration of the motion for admission pro hac vice of William P. Skinner, it is ordered by the court that the motion is granted. Pursuant to Gov.Bar

R. XII(4), counsel shall file a notice of permission to appear pro hac vice with the Supreme Court's Office of Attorney Services within 30 days of the date of this entry.
