FINDINGS OF FACT

{¶1} 1) On January 26, 2007, plaintiff, University Plaza Hotel, filed a complaint against defendant, Department of Rehabilitation and Correction, alleging defendant reserved a room at plaintiff's facility and subsequently cancelled the reservation.

{¶2} 2) Consequently, plaintiff seeks recovery of \$2,000.00, the agreed assessed cancellation fee, plus \$25.00 for filing fee reimbursement. The filing fee was paid.

{¶3} 3) On February 5, 2007, defendant filed an investigation report admitting liability and acknowledging plaintiff suffered damages in the amount of \$2,025.00.

CONCLUSIONS OF LAW

{¶4} 1) Sufficient proof of liability on the part of defendant has been shown. *Ken & Son Towing, Inc. v. Ohio State Hwy. Patrol*, 2005-09499-AD, 2005-Ohio-6814.

{¶5} 2) Plaintiff suffered damages in the amount of \$2,000.00, plus the \$25.00 filing fee. *Bailey v. Ohio Department of Rehabilitation and Correction* (1990), 62 Ohio Misc. 2d 19, 587 N.E. 2d 990.
